JE STATEMENT OF FAITH

1. We believe that the Bible consisting of old and new Testaments only is verbally inspired by the Holy Spirit and is the infallible and authoritative Word of God.

3. We believe that Adam, created in the image of God, was tempted by Satan and fell. Because of Adams's sin all men have guilt imputed, are totally depraved and need to be regenerated by the Holy Spirit for salvation.

5. I agree with Joshua Expeditions that the goal of JE is for each employee to have a lifestyle where "...Christ might have the pre-eminence" Colossians 1:18.
6. I agree to be subject to the authority of the board and administration and wholeheartedly support all policies and procedures of Joshua Expeditions in a positive and affirming fashion with my colleagues, teachers, and travelers. (Romans 13:1)
7. I agree to govern my relationships and duties by the principle of love for one another (I Corinthians 13, I John 3:11).
8. I will focus my efforts on the mission of Joshua Expeditions and not on my personal goals and agenda.

JE SOCIAL MEDIA TERMS

It is very important for all employees of Joshua Expeditions to understand that there are various restrictions and guidelines when it comes to connecting with Joshua Expeditions clients through Social Media and email. As an organization, if we are found to be in breach of any of these guidelines, there is the very real possibility that we could lose our accreditation as an institution of learning. We ask that each of our employees sign this page as acknowledgement of their consent to each of the statements listed below.

1. All JE employees should refrain from giving out their personal information such as email, phone number, and any social media accounts to JE clients, especially to JE travelers.
2. As a JE employee there is no reason whatsoever to ever have private correspondence (email, Facebook Messaging, Twitter Direct Messaging, etc.) with a JE Traveler, especially one who is a minor. **If you are found in breach of this rule, it will be grounds for immediate termination of employment.**
3. While leading a Joshua Expeditions tour, the only Social Media accounts that should be promoted or mentioned to the group are the Social Media accounts that are run by Joshua Expeditions Headquarters.
4. All JE employees should refrain from accepting friend requests on Facebook from any JE Traveler who is either a minor, or currently attending a JE client school. It is best to let your group know this up front, and to direct them to connect with the JE Social Media accounts.
5. All JE employees will acknowledge that anything that is posted on his or her personal blog or social media account will be treated as a personal opinion only, and will completely indemnify Joshua Expeditions of any association with those statements.
6. All JE employees will acknowledge that the only public social media or blog accounts that have the right to speak on the behalf of Joshua Expeditions are the Social Media and Blog accounts run by Joshua Expeditions Headquarters.
7. All JE employees agree to act in the best interest of Joshua Expeditions by promoting the Joshua Expeditions Social Media accounts to their travelers. Please make yourself familiar with each account, and do your best to appropriately reference them to your groups.
8. All JE employees are reminded that the sole reason for traveling with Joshua Expeditions is to promote the goals and mission statement of Joshua Expeditions, and to provide a high quality tour for our clients. The activity of any JE employee who is found to be using Joshua Expeditions tours, travel, or benefits to excessively promote their own ministry, personal brand, or personal accounts in lieu of promoting the goals and mission statement of JE will be brought to the attention of our CEO and Board.
